			validity should be submitted along with the existing NHB Certificate. The Originating Nursery will issue their Letter of Authorization in the official letterhead mentioning the name of the authorized Nursery, item/ variety for which the authorization has been given including the quantity thereof. The said letter of authority, besides the NHB accreditation Certificate of both the Nurseries, along with the application to the NHB for renewal or extension of validity, whichever applicable, are to be uploaded on the website in the folder of Technical Bid.
