I am directed to refer to your Department letter no. 763 / FPI & H / 2E(H) - 24 / 2010 dated the 6th August, 2019 read with letter no. 50 / FPI & H / 2E(H) - 24 / 2010 dated the 11th January, 2019 & letter no. 378 / FPI & H / 2E(H) - 24 / 2010 dated the 27th March, 2017 and subsequent correspondence on the subject as noted above and to state that 147 (one hundred & forty-seven) candidates were interviewed in batches on the 28th, 29th & 30th June and 1st, 2nd, 5th, 6th, 7th, 8th & 9th July, 2021. The Commission recommends the following 49 (forty-nine) candidates for appointment to 49 (forty-nine) temporary but likely to be permanent posts [(9 reserved for S.C., 3 for S.T., 6 for O.B.C.-A (non-creamy layer), 3 for O.B.C.-B (non-creamy layer) candidates and 2 for persons with disabilities (1 each for hearing impairment and locomotor disability or cerebral palsy) of Assistant Director of Horticulture under the Department of Food Processing Industries & Horticulture, Govt. of West Bengal in the order of preference given:-

It will appear from the list that **2 (two) S.C. candidates** have qualified for U.R. vacancies by virtue of their performance at the interviews and as such, they are being recommended against **2 (two) unreserved vacancies** in terms of Notification No. 3662-L dated the 3rd October, 1980/G.O. No. 30(70)-TW/EC dt. 22.01.1997.

No candidate could be recommended for appointment to the remaining 1 (one) post reserved for persons with disabilities (blindness or low vision) as the lone candidate, belonging to this category, was not found suitable at the interview.

The Appointing Authority is requested to verify the following particulars in respect of the recommended candidates before they are offered appointment:—

(i) the statements of the candidates made in the applications regarding date of birth, educational qualifications, caste etc. with reference to the valid original certificates, (ii) the caste certificates as per provisions of the West Bengal Scheduled Caste & Scheduled Tribes (Identification) Act, 1994 and West Bengal Commission for Backward Classes Act, 1993 & subsequent notification no. 6320-BCW/MR-84/10 dated 24th September, 2010, (iii) the Person with Disability certificate(s), issued in accordance with the provision of West Bengal Persons with Disabilities (Reservation of vacancies in Services & Posts) Act, 1995 & (iv) the photographs and signatures of the recommended candidates in the applications.

The Appointing Authority, before appointing a person seeking appointment on the basis of reservation to O.B.C.s should verify the veracity of the Community certificate submitted by the candidate and also the fact that he/she does not fall in the 'creamy layer'.
