NOTIFICATION

No. 1707/FPI & H/2E(H)-25/98 (Pt-II)—27th February, 2003—In exercise of the power conferred by the proviso to article 309 of the Constitution of India, the Governor is pleased hereby to make the following rules regulating the recruitment to the posts under the Department of Food Processing Industries and Horticulture, Government of West Bengal.

RULES

- 1. Short title and commencement-
 - (1) These rules may be called the Food Processing Industries and Horticulture Department (Officers)
 Recruitment Rules, 2002.
 - (2) They shall come into force from the date of its publication in Official Gazette.
- 2. Application—These rules shall apply to the following posts under the Food Processing Industries and Horticulture Department, Government of West Bengal, namely:—
 - (1) (a) Director of Horticulture,
 - (b) Joint Director of Horticulture,
 - (c) Deputy Director of Horticulture / Horticulturist, and
 - (d) Assistant Director of Horticulture / Assistant Horticulturist / Horticulture Development Officer.
- 3. Method of and qualifications required for recruitment—The method of and qualifications required for recruitment to the posts as stated in sub-rule (1) of Rule (2) shall be as detailed below:—
 - (1) (a) Name of the Post: Director of Horticulture.
 - i) Method of recruitment—By promotion, in consultation with the Public Service Commission, West Bengal from the post of Joint Director of Horticulture or the Joint Director of Ag!iculture, having three years of minimum experience as the Joint Director of Horticulture or the Joint Director of Agriculture.
 - ii) Essential qualifications for recruitment—

- (A) A first class post graduate degree / second class post graduate degree with a first class bachelor degree in Horticulture / Agriculture with Horticulture as an elective subject from a recognised University;
- (B) Adequate administrative experience in Horticulture and organising ability.
- (b) Name of the Post: Joint Director of Horticulture.
 - i) Method of recruitment—By promotion, in consultation with the Public Service Commission, West Bengal from the post of Deputy Director of Horticulture / Horticulturist, having five years minimum experience as the Deputy Director of Horticulture or Horticulturist.
- (c) Name of the Post: Deputy Director of Horticulture / Horticulturist.
 - i) Method of recruitment—By promotion, in consultation with the Public Service Commission, West Bengal from the post of Assistant Director of Horticulture / Assistant Horticulturist / Horticultural Development Officer, having five years minimum service as the Assistant Director of Horticulture / Assistant Horticulturist / Horticultural Development Officer.
- (d) Name of the Post: Assistant Director of Horticulture / Assistant Horticulturist / Horticultural Development Officer.

i) Method of Direct recruitment—By selection (direct recruitment) through the Public Service Commission, West Bengal.

- ii) Essential qualifications for direct recruitment—
 - (A) A Bachelor degree in Horticulture / Agriculture with Hortucilture as an elective subject from a recognised University;

(B) Knowledge of Bengali spoken and written.

- iii) Desirable-Masters degree in Horticulture from a recognised University.
- iv) Age—Not more than 32 (thirty two) years as on the 1st January of the year of advertisement (relaxable for Scheduled Castes/Scheduled Tribes/Other Backward Communities) as per rules for the time being in force.
- v) Confirmation in the said posts after successful completion of 3 (three) years and other rules as applicable.

 - (v) Omit "(v)" under rule 3 (d) along with the entries relating thereto;
 - (vi) after rule 3(d) insert the following rule -
 - "(e) Name of the post: Horticulture Extension officer"

Method of recruitment:

By promotion in consultation with the Public Service Commission, West Bengal, from amongst Assistant Horticultural Extension Officer having put in 10 years of minium service as such."
